RipWing CrossFit/River Town Athletic Co. Liability Release - Emergency Contact Information - Participant Agreement

RELEASE: In consideration of the above mentioned risks and hazards and in consideration of the fact that I am willingly and voluntarily participating in the activities offered by River Town Athletic Company, I, the undersigned hereby release River Town Athletic Company, their principles, agents, employees, and volunteers from any and all liability, claims, demands, action or right of action, which are related to, a rise out of, or in any way connected with my participation in this activity, including those allegedly attributed to the negligent act or omission of the above mentioned parties. This agreement shall be binding upon me, my successors, representatives, heirs, executors, signs, or transferees. If any portion of this agreement is held invalid, I agree that the remainder of the agreement shall remain in full legal force and effect.

If I am signing on the behalf of a minor child, I also give full permission for any person connected with River Town Athletic Company, to administer first aid and if deemed necessary, and in case of serious illness or injury, I give permission to call for medical or surgical care for the child and to transport the child to a medical facility deemed necessary for the well-being of the child.

This includes but is not limited to, recreational areas, playground, areas adjacent to main building, and for any area selected for training by River Town Athletic Company.
